#### 3. Parent Expectations

- ❖ I agree to bring my child to our scheduled weekly session 10-15 minutes early to warm up and stretch
- ❖ I understand that if we are late to the session we will forfeit the time
- ❖ (All sessions last 60 minutes)
- ❖ I agree to Coach Dario's 24 hour "no reschedule policy"
- ❖ I understand that my child has 24/7 access to Coach Dario through delanossocceracademy@gmail.com to ask him any questions throughout the week
- ❖ I understand that during the sessions, I will not pressure my child or yell from the sidelines. We train in a "non-pressured" environment
- ❖ I understand that Coach Dario will decide the "rain-out's" or rescheduled sessions due to weather. (*He will always check field conditions before the sessions and will communicate via text message if there is a cancellation*).
- ❖ I understand to communicate with Coach Dario (and send him an email if and when there are conflicts/vacations in advance) so we can reschedule sessions in a timely manner
- ❖ I understand that if we are "out of town" or "on holidays" that we are still a member of the 5 or 10 months program. Coach Dario prefers to complete any rescheduled sessions before you depart for vacations. Please communicate with Delano's Soccer Academy when you are going out of town so we can plan accordingly
- ❖ I understand that we will complete 22 sessions within the 5 months and, 40 within 10 months agreement.
- ❖ I understand that Coach Dario's billing process is an automatic electronic funds transfer (every 30 days from the original payment)
- ❖ I understand that if I have a "failed credit/debit card payment" I will need to register with a new credit or debit card within 48 hours of the failed payment.
- ❖ I understand Coach Dario's early contract termination policy stated on DSA's website
- ❖ I understand (according to Coach Dario's liability release form) that Delano's Soccer Academy, Coach Dario and any assistant coach for Delano's Soccer Academy is not liable for any injuries.
